



### **NEC** announces executive personnel changes

TOKYO, January 30, 2024 - NEC Corporation ("NEC"; TSE: 6701) today announced executive personnel changes that will become effective as of April 1, 2024, as well as executive personnel changes to be proposed on the date of the Ordinary General Meeting of Shareholders (GMS) scheduled to be held in June 2024.

In order to strengthen corporate governance and boost management speed NEC transitioned to a Company with a Nominating Committee, etc. in June 2023. Now, with the aim of accelerating the reform of the Board of Directors, NEC will increase the number of independent outside directors by one, increasing the ratio of outside directors and strengthening diversity. Additionally, on the executive side, NEC will renew the management structure for strongly promoting strategy execution aimed at achieving the Mid-term Management Plan 2025, including the appointment of three new executive personnel.
