





NEC announces executive personnel changes

TOKYO, January 30, 2025 - NEC Corporation ("NEC"; TSE: 6701) today announced executive personnel changes that will become effective as of April 1, 2025, as well as executive personnel changes to be proposed on the date of the Ordinary General Meeting of Shareholders (GMS) scheduled to be held in June 2025.

As a Company with a Nominating Committee, etc., NEC will adopt a more compact structure to further strengthen the monitoring function of the Board of Directors, and will increase the ratio of independent outside directors and strengthen diversity. Specifically, the number of internal directors will be reduced to three, with the CEO at the center, and the total number of directors will be 11.

Additionally, on the executive side, NEC will appoint 10 new executives, including foreign nationals, based on the concept of "the right time, the right place, the right person", and will build a management structure that will strongly promote the implementation of strategies aimed at achieving the Mid-term Management Plan 2025 and realizing sustainable growth.
